End of year banquet – Doug Bates, through the Kaitlyn Bates Initiative, want to contribute \$500 towards a scholarship. We need to submit in writing the criteria for it to be approved.

First Shift – 12 registrations in the last 4 days. 26 registrations to date. The Nighthawks are subsidizing novices \$100 for their first year. Do we want to do the same. If we max out registrations, we get a subsidy back from Hockey Canada. Jan 29 @ 6:30 is the initiation and fitting. Feb. 11 is the first day but Greg can't go so will need someone to take charge that day. He wants 2 assistants for the whole thing, as well as 4 parents. They prefer not to have kids below Midget age helping. Six 1 hr. sessions for 6-10 year olds. There is a waiting list if it gets full. Feb. 11, 18, 25, March 4, 25, April 1 (approx. 2 or 3 pm). He needs 3 off- ice helpers, too.

Overtime Hockey – There is a new contract bringing development to Cobourg. Greg has had a lot of inquiries about individual player development. They have a contract with the CCC.

He wants to renew the development package. It seemed to go very well this year with all teams. (Goalie, rep, HL). Feedback from Trudy and Spike was that skating seemed to be the biggest most important focus.

Rep tryouts - all competitive tournaments including provincials are completed Sunday April 8th, tryouts I think will be able to start 48hrs later. I am suggesting we wait a full week before we start our tryouts, I will book them this year so that there is time between each tryout unlike last year where they were all crammed in before the RBC Cup. This will also give any of our girls that are wishing to tryout at a higher level than we are offering at another center a change to go and see. I feel if they are good enough to make those teams and want to go we shouldn't be holding them back. Also I know Ken Pederson our Midget AA coach(if he stays as our Midget

AA head coach) likes to have later tryouts so that girls can filter down to our program. This isn't ideally how we'd like our program to be run but its what happens for us.

As far as ladies league ice, I have booked the pond March 3rd 8-9pm and 9-10pm for recreation wrap up day as requested.

Ladies league as far as I can remember has always ended first week of March because they play in the Memorial and Memorial closes the first weekend in March. Last year we got it opened for an extra weekend, so they could have one more Monday night. Coincidently this is the first year that the ladies no longer pay the minor hockey rental rate too.

Still unsure of which time the ladies league is going to be running at for the remainder of the season, are they starting at 6pm or 7pm, if start time is going to continue at 7pm(which is what I think the final decision was) then I would like to see if the Novice team who has the ice at 5-6pm would like to bump back to the 6-7pm time, before I give an hour back or sell it to Nighthawks.
