NEW BUSINESS:

1. Concussion Testing – Concussion baseline testing is recommended but not mandatory. Shannon said the mandatory concussion protocol should be followed regardless of whether the baseline test was done or not. Lynn Marie said there is a more thorough 45 minute baseline physical exam available, through the Sports Injury Clinic (Jeff Crowley). Baseline testing is not mandatory through the OWHA. Action – Veronica will let teams know that baseline concussion testing is optional & that the Sports Injury Clinic will be open on the first PD Day for baseline testing. Curtis made a motion that baseline concussion testing is encouraged but not mandated, since it's not currently mandated by the WNGHA. 2nd – Jen. Carried.

- 2. Shannon World Girls Hockey Weekend → Shannon will send the link to the managers and coach's regarding Oct 6-8's World Girl's Hockey Weekend. There are all kinds of suggested activities for this weekend. Hockey Day is Sept. 29 which will link in to this.
 - Fundraising Shannon wondered if we'd like to do a big fundraising event run by WNGHA. Shannon will send out a survey to coaches to see if there is an interest.
- 3. Veronica Hockey Canada Gender Identity Course Veronica sent out an email and brought it out at the coach/manager meeting. Curtis described the online training course that is not currently mandatory through the OWHA. It's a 90 minutes on-line course that is free. OMHA and other organizations have made it mandatory. Curtis said all staff should be encouraged to take this. Shannon stated it is currently built into the coach certification courses.

Darren Mackey – Ice Scheduler
