- 9. Ron Banquet booked for April 9 (Tuesday night). Toad will MC and organize the banquet. Action Shannon will network with Toad and compile food list. We need a raffle license and raffle tickets. Action Shannon & Ian will apply for the raffle license. We need donations for the raffle draws. Action Toad will touch base with Lyndon to see if he can ask sponsors if they want to donate something for raffle at banquet. Action Ryan will ask Veronica where we got the banquet tickets last year and then he will get them printed. Scholarship We will proceed with the scholarship. Details will be decided at the next meeting. Action Ryan will post the
